

Chesterfield Kids Deserve School Funding

Now: Tax Breaks Can Wait

Jackie Halaw **started this petition to** Chesterfield Township Board of Education **and 2 others**

Chesterfield School District is expected to receive an additional \$1,582,592 in state aid for the 2018-2019 school year. We have gone from 9.5% to 58% of our state aid due to the persistence and relentless hard work of many community members and elected officials in the fight for fair school funding.

The undersigned Chesterfield residents request that all the additional funds we will receive for the 18-19 school year should be absorbed into the school budget and capital reserve in order to rectify the chronic underfunding that has impacted the children of this community. We request that any tax breaks being considered should be postponed for at least one school year.

We respectfully request that you consider the following as you determine how these funds will be spent:

- Settle the Teachers'
 Contract: Teachers impact student
 achievement more than any other aspect of
 schooling. Our teachers and staff deserve a
 fair contract and funds should be allotted to
 settle their expired contract as quickly as
 possible. They should receive at least the
 county average settlement.
- Improve Curriculum and Instruction: During years of underfunding, curriculum and instruction has been shortchanged. More curriculum kits and resources should be purchased where they have been reduced in past years and shared among teachers. Professional development for staff is needed to properly implement the boardapproved curriculum and continue the program review cycle. We need to expand the arts, music, STEM, and Gifted & Talented programs. Supplemental resources are needed to sufficiently challenge all learners at all levels throughout the content areas in order to provide an education that is equitable with the other Northern Burlington sending districts.
- Keep Class Sizes Small and Ensure Proper Staffing of Teachers and Paraprofessionals: The school needs to be properly staffed with an adequate number of teachers, guidance counselors, physical education, art, library, and music teachers to meet the rigorous requirements of the NJ Student Learning Standards and NJ statutes. We need district-employed paraprofessionals, not outsourced employees, to support some of our most challenged students.

The New Jersey State Constitution guarantees a "thorough and efficient education" for all New Jersey children. Each year the state calculates the "Adequacy Budget" or the amount of money to provide the constitutionally-mandated thorough and efficient education for every school district. Chesterfield has, until now, been unable to reach the adequacy budget and has a cumulative adequacy deficit that has in turn negatively impacted the curricula, programming, and resources at Chesterfield Elementary School. Even with taxpayers trying to make up for the severe state underfunding, our school has operated with an Adequacy Deficit of over \$5.8 million dollars in just the last three school years. That is a three-year cumulative deficit of over \$7500 per student.

Our teachers and staff have done more with less, and our community has rallied by paying more than our local fair share of taxes and by fundraising extensively. Despite our community's best efforts, our children have been deprived of an education comparable with surrounding communities. The education and welfare of the children must be the primary focus and be rectified first and foremost.

This fight for fair funding is not over and although we may possibly be on the path to a fair solution, it is premature to offer tax relief at this early stage. There are no guarantees that we will receive a higher percentage of state aid next year even if A2/S2 is signed into law. If the state does not pull in the projected revenues, then they will not have the funding to increase school aid. We must use this funding wisely and for the benefit of Chesterfield's children while considering the long-term goals of full funding and tax relief.

Good evening. I am once again writing to express my opinion regarding the use of the state funding. I am disgusted and so, so disappointed that the residents of Chesterfield who fought so hard for additional state funding now have to fight our own board to use the money for our kids. Those of us fighting were not fighting for tax relief, we were fighting for more educational opportunities for our children. To take \$214,000, which could be used for so many things at the school, and use it for a measly \$111/household/year tax cut is a slap in the face to everyone who gave time, energy and tears to the funding efforts.

The facts facing our district are such that even with the additional funding, we are only funded at 56% of our fair funding amount. Our school has a lot of needs, whether or not they were in Mr. Heino's original budget proposal. Until (a) we are close to 80% of the state funding we should be receiving, (b) our teachers have a contract, (c) we have adequate or any STEM programs, and (d) we have sufficient technology, consisting of more than 1-1 tech for a few classes, I do not see how tax relief is at all in the education welfare of the children. I believe the Board has an ethical duty, and notwithstanding the guidance from the state on the use of additional funds permitting tax relief, the facts as they pertain to Chesterfield do not permit the Board to grant tax relief.

I also ask that the Board promptly settle the contract with the teachers' union. The updated budget proposal includes after school programs and family nights. How does the Board plan to provide these, notwithstanding the funding, if there is no contract with the teachers? The lack of the contract, not funding, prevented clubs from occurring last year. How does the Board expect to have a functioning school if we start another year without the contract in place? We cannot have another year of no bulletin boards, no clubs, limited teacher participation in events, and bad morale. Please work with the union to promptly finalize the contract. The teachers have the support of most of the public, and we are waiting for the Board to act.

I would also like to again reiterate that absent a state directive, tax relief seems to be an invitation to the state to discontinue any additional funding received this year in the next few years. We all know that this fight will continue for years as state budgets are negotiated and the now-overfunded districts fight to retain their overfunding in court and at the state house. It will be an uphill battle for Chesterfield to argue that we must retain our additional funding and receive more funding to get us closer to 100% when the funds we did receive were used to provide a relatively small amount of tax relief per household. This will be compared to overfunded districts who will be yelling about all the educational services they must cut because of their loss of state aid. I can envision the soundbites now, stating that a wealthy district like Chesterfield with a median income of over \$140,000/year/household (using Terran's numbers) used part of its new state funding to provide a \$250/household tax refund (assuming roughly 1/3 of the additional \$1.5 million in state funding is used for a refund, based on my rough calculation of 2000 households in Chesterfield) while Jersey City, with a median household income of \$60,703 (taken from the US Census website), was forced to raise its taxes because its aid was reallocated to Chesterfield. I suggest that the Board consult with its attorney and the state board of ed, and perhaps someone from Senator Sweeney's office, before making any decisions to use funds for tax relief.

A couple of notes regarding your proposed revised plan for the additional state aid:

First off, I see no necessity for a tax relief of \$111/household especially if it comes to cutting items from the budget that have proven benefits to the education of Chesterfield students. I do however have a serious issue with just spending the money anywhere just because we now have it. It seems that the Board of Education and the School Administrators have not considered a few items to include 1. this money is not guaranteed past this year 2. we are still not funded at 100% and 3. those districts that are now set to lose funding will be scrutinizing how we are spending what they believe is their money and will be gunning for us. If the residents of Chesterfield are questioning some of your line items in your proposal what do you think these districts will do with that info?

Please answer the following:

- A. Are the proposed added staff 1-year contract positions tenured positions and or union positions with benefits? to include the school psychologist, the part time secretary, the library aid and the instructional coaches. Also, will the change from PT to FT G&T and music teacher now be benefit able positions?
- B. Also, Mr. Heino stated in his original presentation that the instructional coaches are to be put in place to assist the Administrator of Curriculum not necessarily to coach our teachers, please clarify how they will be used currently and in the future.
- C. Mr. Heino also stated that currently we use "consultants" to do the job that the instructional coaches will be doing. Could you elaborate on the cost to use consultants and the cost difference in paying a part time consultant or even fulltime consultant compared to hiring a fulltime instructional coach including benefit costs.
- 2. According to the March 2018 Budget Proposal power point presentation the following items were cut because of lack of funds: Special Education Teacher, PT World Language Teacher, District Employed Occupational Therapist, Curriculum resources, Social Studies Program, Special Education (Out of District Work Shops & supplies) Extra compensation and buildings & Grounds to include (HVAC, Electrical, Security, Geothermal Vault & Roofing). I'd like clarification on the following based on your new revised plan on the following items:
- A. PT world language teacher-this was an item cut but not added back in when the new money came in- why? and is the PT world language teacher not a needed expense while we add a PT music teacher to run a "new" program to the district "Chorus" and changing the PT G&T teacher who serves less than 10% of the student population more in need than the PT World Language teacher? Please explain.
- B. District Employed Occupational Therapist another item that was cut but not added back in. Is the district no longer providing OT to students? Why is this item no longer a need?

 C. Under Buildings and Grounds I do not see the following as cut: Bike Racks and bricks out front at \$35,000, Cafeteria table replacement at \$34,000 or Enno board replacement at \$88,000 but are now needed desperately? Did they just start falling apart? Are these items that could wait and use that money to possibly bring back board funded field trips which will directly affect the education of the students?
- D. I'm struggling with these instructional coaches that were not in the budget in March but again are desperately needed now, Can the effect on staff be reached by using Professional Development workshops, webinars etc.? Can't we increase the professional development budget and not hire a permanent staff?

E. Those darn bricks and those bike racks: What alternate solutions were sought such as grants for the bike rack area, cost to seal bricks instead of pouring concrete etc.? \$35,000 for something that has no educational benefits? There's got to be a better and less expensive solution.

F. What items on this proposed budget have you looked to get covered by alternative funding sources such as grants or in the case of the building maintenance on a 7-year-old building going back to contractors and warranties or fixing and repairing instead of replacing?

G. On the items that you plan on spreading across multiple years, do you have a plan in place if we do not get funded the same next year or are we "stuck" in spending this money which will result in the tax payer making up for the shortfall of more cuts to educational programs?

H. Why are you proposing to now pay for the cost of Science Olympiad which benefits 20-22 kids but not proposing to cover the cost of field trips which effects all students? The Science Olympiad was a parent/CPEF supported grant in the past, can't it continue to be this way until we are fully funded and there can be some "real tax relief down the road?

I apologize for the length and quantity of my questions however since the Board of Education does not allow for a back and forth question time during public comments of meeting I feel that this is the only way to get some answers. I am sure that I will need to come back for additional clarification once I receive your answers. I truly look forward to your responses to my above

Additionally, I implore you all to review these items as well as the rest of your plan before giving a backhanded tax relief of \$111 which I question is just a political move. I also request that a school budget committee is created to include members of the school board and administration, community members and township committee members in hopes that some other sources of funding can be found (grants etc.) as well as provide the community with transparency. The Board of Education has stated many times that they are working closely with the Township Committee however that is not how it looks to the community. Your actions will speak louder than words.

I have included all members of the township committee on the email in hopes that they too are interested in assisting you in planning for the school budget.

Dear Board of Education members,

I am writing on behalf of myself and my family to express my utter disappointment in reading the budget proposal posted on the school's website. According to this proposal it would seem the Board of Education members are prioritizing placating the louder voices in town who are clamoring for a tax refund instead of working in the best interest of the school, the teachers, and the children of this community who have all been in a funding crisis for years. And so I ask, why did you run for Board of Education if you were more interested in placating township members than working in the best interest of the school?

Why are you of the opinion that a school that has been in a funding crisis for years, and is still only funded at 58% and is desperate need of catching up on all the updates, repairs, and academic programs that have had to be put on hold and which will cost above and beyond what 58% can cover, should instead spend the money of a partially funded school to placate loud voices with a menial tax refund?

Did you know that the cost of this absurd tax refund, \$214,429.00, is 13.9% of the total amount you are receiving in state funding? In making the outrageous choice to spend 13.9% of the monies received from the state on a frivolous \$111 tax refund, you are in fact dropping the percentage of funding for the school, teachers, and children significantly. A school that was just two months ago in a funding crisis is now facing their own Board of Education's plan to take money away from them. Money that the school desperately needs and that our teachers and children deserve.

Since you seem more interested in township issues than school issues, did you know that according to The National Bureau of Economic Research, "A \$1.00 increase in per pupil state aid increases aggregate per pupil housing values by about \$20.00, indicating that potential residents value education expenditure."* Meaning that if you took that meager \$111 you are planning on sending to my husband and I, and instead invested it back into the school, our home value would increase by approximately \$2200. Do you honestly think we want \$111 cash compared to an increase home value of \$2200? And \$214,429.00 invested in the school would equal an approximate total increase in home values for the entire town of \$4,288,580.00. But instead of an overall boost for our entire town's home values, you've chosen to distribute \$111.00 to each home as a bandaid for our high taxes. Our taxes are high, they are an issue, but to hand out a menial tax refund at the expense of the school and our home values seems outrageously shortsighted.

Why did you send celebratory and congratulatory emails and texts to me after the hard work and dedication of so many community members resulted in the school being funded at 58%, when your plan all along was to turn your back on that hard work and waste the money on a menial tax refund?

In conclusion, I do not expect any answers from you as I have received almost no communication from the Board of Education in the 14 years that I have lived in this town, however I would like my letter to become part of the public record.

Subject: Budget 2018-2019 and Tax Relief

Dear Board of Education Members, Mr. Heino, Mr. Pisano:

While you often see me at the Board Meetings, I don't believe I have ever actually ever spoken during public comment. It is actually kind of crazy, I know, since I am very vocal within the community on initiatives that do not always impact the school. I do also want to point out, that I am also very vocal and outgoing on many things that are related to the school and have volunteered for more things that I actually care to admit. Time on all these initiatives is just that - - Time. Time taken away from my own kids for the betterment of all kids. Let me reiterate that, *the betterment of ALL kids*.

I have been a resident of Chesterfield for almost 11 years and my children have been attending Chesterfield Elementary for what will be our 7th year this fall. I've seen a lot of changes over those 7 years and they have not always been great. As a matter of fact, I feel as if the school makes less and less of an effort in just about everything. I've been witness to years of excuses as to why our school does without or does not do well with things. Those excuses originally started with things like "well we're in a new school" to "we just got too big too fast" to "we went from a school with 200 kids to now over 700" to "we just don't have the staff or space" to "we just don't have the money". It was excuse after excuse without any real change or impact. The school has been doing the bare minimum with more and more parents stepping up do take part in activities or events to make school a fun, hopeful, all inclusive place to learn.

I am a full time working mom, with three children that are very busy little people. Yet, when it came to the fight for fair funding, I, as a concerned community member, did what I could. I attended a meeting at the state house, called our legislators and governors, wrote letters, challenged the NJEA on a pretty regular basis via social media, had my children be part of a fair funding video, attended meetings and gatherings, letter writing campaigns, information sessions, and well you get the point. I did not do it for \$111. As a matter of fact, if you count up all the hours I probably put into the fair funding, let's just say 25 hours to be conservative and calculate that based on my hourly rate on what I would charge to provide my regulatory specialists advice to clients, I should receive back \$14,875.

I did not do what I did for \$111. I did not have my kids do what they did for \$111. It would not have been worth my time. I implore you all as Board Members, educators and as the business administrator to do your research on the impact of keeping that money in the SCHOOL and what it will do for our <u>town and the kids</u>. There is research* that evidences that just a \$1 increase, housing values go up by \$20. So, please keep the \$111 tax credit, as I would much rather have the \$2200 go back into the value of my home.

Now, I want to go back to the fact that I have lived here for 11 years because like many residents, we all have a tax story. that reads pretty much the same. When I first moved here, I think my taxes were around 8k. They went up to 10K. Did not care, as I come from a family of people who worked in professions such as police, fire and teachers and I can clearly see where the money was going. Taxes went up to 12K. Still not an issue. I was somewhat happy with the school, our police department is great, I still thought it was all worth it. When my oldest really started to struggle academically and there were times that I did not think my son was safe at school due to bullying and the school doing pretty much nothing about it, I started to think differently because I thought private school was going to have to be an option for us. Thinking to myself, why continue to pay such high taxes for an education that I thought was sub par at best. We decided to stick it out, bought a house on the other side of the school, and I was okay with my taxes being 17K a year and with that, became involved in the fight for fair funding. The only way to fix the tax issue was to fight for what was ours in the fair funding formula.

When we received word that CES was going to receive 58% of its funding. I was elated!

I thought as a school community, we could turn a corner and really start to think how we can make things better. Just a few things come to mind: a FAIR CONTRACT for our TEACHERS and STAFF, programs that would really allow the administration to develop better curriculum not only in our subjects (e.g. social studies, reading, etc.) but also for specials such as Technology and Art, Professional Development for our teachers and let's face it, you really need to work on team building. From my point of view somewhere along the line, a hostile working environment has been created. I want the school to use the money, use it wisely, because you are out of excuses. You have to make this work and work with what you have and please do not be so ignorant, as to just give it away. Either way, there will be no more excuses, NONE. You should have what you need to make this school a better learning environment, for everyone.

I want to be clear, I DO NOT WANT \$111 back in tax credit. Please allow yourselves as a Board and an Administration to understand where the parents are coming from. To understand that we did not do this for tax credits to be in the plan for year one. We should not be discussing tax credits until we are 100% FUNDED!

From an outsider looking in, I believe Mr. Shah may be influencing the Administration and other Board Members to thinking that the tax credit is the way to go because his long term goals includes a possible run with the township. Do not let his personal goal, or that of other board members, be used to shortchange the kids or the efforts of our community.

I also want to be clear that as a member of this community, I am prepared to take legal action against this board for violating your own bylaws (e.g. 9271 states, "I will make decisions in terms of the educational welfare of the children..."). Considering we are still underfunded. I do not believe you are within your legal rights to provide tax relief. Also, because what I feel is unjust and not within your rights as Board Members, I am looking into what the rights I, as a community member may have to remove you from being a Board Member, if any Board Members vote in favor of a budget that includes tax relief.

Finally, I would like to point out that I, as concerned member of this school community, do feel that Mr. Shah in particular is what I would refer to as anti-teacher and as a result, he is a main reason why the teachers and staff of CES do not have a current contract. I would make the recommendation that he should no longer be part of the committee that negotiates the contracts. Clearly there is a problem, I implore you as a Board to start thinking of ways in which it can be less hostile, more respectful for the betterment of everyone involved, including the KIDS!
