## Chesterfield Board of Education and Administration-

This letter is being written after my most recent comments that were spoken during public comments on February 24, 2021. It was very disheartening that no comments regarding the number of students in decline, the hiring of a new administrator, no comments regarding the tax impact on a proposed Warehouse that would have an impact on our taxes, the Old School otherwise known as the Crosswicks Firehouse is still sitting vacant and explanation was not provided in my opinion on most of these items.

The District last year received additional State Aid and this Board made the decision against the request of Taxpayers to not return anything and even went to cap in 2020. According to the Dept. of Education, Chesterfield will be receiving over \$540,000 in aid, which is bringing the total aid to over \$3.2 million. Your auditor's presentation shows a very high number in reserve and would like to point out that any money whether from the State or taxes belongs to the TAXPAYERS and not the school. The time has come to tighten this budget and start returning. Every year when Board members run, they promise to give back and work towards those who pay, but for some reason, this has not been happening with this Board year after year. You owe it to those in Chesterfield to show some tax relief once you received it, but instead, last year you hired a new Principal on top of already having one and here we are now fighting a lawsuit during Covid. While this new hire is an interim, \$28,000 plus a pending lawsuit and Covid is what many in the community, including myself sees as "Top Heavy" and irresponsible.

Your report as of February 24th, 2021, shows 716 students and back in 2017, we had over 799. We now have less students with now 3 Paid Principals and a Superintendent. That is totally unreasonable and financially irresponsible. That \$28,000 could and should have been returned to the tax burden. We all understand tough times and we all understand Budgets, but why is the WANT list more important than a true NEED list. These are difficult times for so many people, especially our children. Your responsible for being responsible and you are not. The Budget is not and should not be a BLANK CHECK and you refuse to allow a Budget Advisory Committee from the community to review things and be transparent like the Twp. Committee does. WHY???? You are asked questions for explanation and you refuse to respond. WHY????

The Crosswicks Firehouse is the Property of the School and has been a known fact for a long time when we were building the new school in 2008. Now that the property is no longer occupied by the Crosswicks firehouse, lets learn by prior situations. When we built the new school, the prior school built in 1964 had to be demolished because of mold and the amount of time it sat vacant. At the March 2021 Twp. meeting we now must demolish the other OLD School that housed the Township offices, due to the fact that 2 sitting Committee members spent the last 3 years trying to get this building used by the Library or some sort of community center. Again, the value 3 years ago depreciated more than half and the cost to remediate exceeds the value and has been voted to be demolished. The time has come to sell it and use the money to pay off the existing debt on the current school.

Finally, this Board is fully aware of a pending proposal regarding the OYCC, otherwise known as the Old York Country Club. This will have a huge impact as a ratable and to date, we have heard no comments from any Board members or the Proposal. I do know that there are Board members attending the Zoom meetings (see attached) with those who are against this proposal. This is very concerning to me and many in the community are not happy that any Voted Committee person would attend or have any opinion on these calls. At this time, the Twp. Committee and Planning Board members were instructed and told that at no time should they be attending these resident meetings and having any opinions. Why is it once again the Board feels they are exempt from this? You refuse transparency with not allowing a Budget Advisory Committee and you are attending meetings that may shade your opinion for what might or might not benefit a community and our future budgets. I personally have not made my opinion and await to hear and see the studies and information on the proposal on 3/18/21. Sadly, many in the community are sharing opinions and not facts and that will taint the community and especially when they know some have chosen to attend these meetings and sessions while representing an entire community. Your commitment is to remain neutral and represent all. Seeing names of representatives such as Jackie Halaw and Andrea Katz as in attendance throws up RED flags immediately and hearsay states that both have spoken on these calls which was not in public session at a listed public meeting.



Hope you are well. You posted false information that school board members are running the meetings opposing the warehouses. That is not true and I am asking that you remove that post. Agnes Marsala has been the person organizing the information meetings and started the petition.

I do not have a position about the OYCC warehouse development nor have I signed the petition made by Agnes because I don't know enough about the project yet. I do have environmental and traffic concerns that I hope will be addressed as the community learns more.

In the informational meetings run by Agnes, I did not give my personal opinion about the development. The only time I chimed in was to give a suggestion to Agnes to OPRA request the correspondence between OYCC developers and the township. And, when they were discussing residents who would potentially be affected, I suggested reaching out to the nuns living at Saint Claire's monastery and the Kusers so that they can learn about the proposed development and weigh in with the township with their perspectives.
